Email Notification Authorization

The reunion committee currently maintains an automated email list that allows us to quickly forward email notifications to classmates who have authorized us to communicate reunion information via email. The service is both efficient and secure. The use of this online notification system will ultimately result in savings of postage and time while allowing us to keep you up-to-date on reunion matters with little delay.

The committee plans to maintain this automated email service even after the 20-year reunion has come and gone. Notices forwarded via the system will be kept to a minimum and will be limited to matters such as: semi-annual reminders requesting classmates to update your contact info for future reunions; notification of occasional classmate informal get-togethers; notification of special news involving classmates; notification of classmate deaths; etc. We expect the number of such notifications to number less than 6 a year. We believe this service will allow us to maintain contact during non-reunion years and help to bolster reunion participation in years to come.

The email list is maintained in a secure password-protected website which may only be accessed by authorized committee members. The committee assures all classmates that this service will never be used for advertising or other types of spam.
